While we acknowledge the importance of the government's aims behind the proposals, NGA does not agree that introducing minimum service levels is the appropriate way of achieving them. In a survey of our members, 62% disagreed (46% strongly disagreed and 16% disagreed) with introducing minimum service levels.

These measures potentially undermine the basic right of employees to strike and put employers in the uncomfortable position of having to decide which workers to include in a work notice. The potential workload implications of implementing the proposals are also concerning, particularly at a time when reducing teacher workload is meant to be a priority for the department. It may also further the recruitment and retention issues currently facing the profession.

We would stress that the DfE should instead seek to spend significantly more time in engaging in meaningful dialogue with the sector, including the unions and sector bodies, with the aim of arriving at a voluntary, co-created proposal.

NGA believes that the government should be making greater efforts to engage with trade unions to reach a voluntary agreement and to try to address the fundamental issues behind why teachers choose to strike in the first place.

We agree on the need to adapt to certain circumstances by providing remote education opportunities - there is a fundamental right for children and young people to access continued learning, in an appropriate and well resourced learning environment.

However, in the wider context of the proposal, which in this instance is intrinsically linked to the question being asked about remote learning, the MSL approach as a collective proposal undermines the basic rights of employees and we are therefore not able to support any element of the proposal due to the likely intended impact of taking such action.

We would again stress that the DfE should instead seek to spend significantly more time in engaging in meaningful dialogue with the sector, including the unions and sector bodies, with the aim of arriving at a voluntary, co-created proposal.
