Our first speaker was Professor Lucy Easthope, author of the forthcoming book entitled "When the Dust Settles", discussing key themes around Disaster Recovery including what lessons should we learn from the pandemic so far and what can we do to support our pupils, staff and community in the next stage of the pandemic. Lucy has advised government departments, corporations, emergency and health services and charities during the pandemic and has been a leading authority on recovering from disaster for over two decades during which she has challenged others to think differently about what comes next after tragic events.

JANUARY — SECONDARY/POST-16 GOVERNORS NETWORKING EVENT

This event was designed specifically for governors of secondary schools and post-16 settings. Covid-19 meant a couple of delegates had to drop out last minute, however those of us left had the advantage of really in-depth discussions of subjects raised!

After introductions the first subject covered was what views people had about the last two years. All present were concerned about the effects both short—term and long—term of the last two years on pupils and staff of schools. It was felt that it was easier to recognise and deal with the shorter-term effects of the last two years. As was pointed out for pupils who have been in reception and year 1 in the last twelve months, it will be another 6 years before those pupils join a secondary school. So very difficult to be sure about the possible long-term effects.

There were both positive and negative aspects to the last two years. Positive in that governance has adapted well to the new situation with virtual meetings generally being well received. Also positive in that it was felt that governance has changed and that there can be no going back to the situation pre covid. Different schools have adopted different procedures in terms of what meetings are virtual and what meetings are face-to-face.

Governors were concerned that they have not been able to attend schools as much as they would like, which led to a discussion over how different governing boards have handled going into school. The big issue for schools is the effect of covid on staff, especially senior staff, and how they have kept going over the last two years. Concern was expressed over staff wellbeing over the next 12 months.

Another major subject of discussion was around finance. Governors were reporting that at present schools had received extra funding, which was very welcome. They were however concerned that these extra funds were expected to be spent quickly whereas the general feeling was that we needed an extended period of extra funding to ensure that all gaps were addressed in pupil's learning and knowledge.

In all a great networking event for those that attended, with all present learning and understanding more about what is happening in other secondary/post-16 settings in CWAC.
